

# Reminder return to school testing in January

The Department for Education have informed schools that all students will need to test for COVID-19 before returning to school. Therefore, we plan to organise **testing on site on Tuesday 4<sup>th</sup> and Wednesday 5<sup>th</sup> January 2022**. Parents may choose, however, to test their child at home instead.

If you would like your child to come into school on the above days to undertake their COVID test, please complete the form <a href="here">here</a> by Tuesday 14<sup>th</sup> December. Alternatively, as stated above, students can test at home and register results online via Test Register in the usual way.

We emailed information to parents and students at the start of the week about arrangements for the first week back in January. Information is attached to this email and the letter can be downloaded from our letter library on the website <a href="here">here</a>. The key information from the letter is included below:

Monday 3rd January 2022 is a bank holiday.

The Department for Education have informed schools that all students will need to test for COVID-19 before returning to school. Therefore, we plan to organise testing on site on Tuesday 4th and Wednesday 5th January 2022:

- Years 7-9 on Tuesday 4th January 2022 (KS3)
- Years 10-13 on Wednesday 5th January 2022 (KS4/5)

Students in Year 11 will be in lessons and 13 will be undertaking their PPEs on Tuesday 4th January and Wednesday 5th January. On those two days Years 7, 8, 9, 10 and 12 will have work set to undertake at home. Please note that there will be no live lessons on these two days. **On Thursday 6th January 2022 all students will return to school.** 

#### C2C Travel

Following the recent government announcement in relation to the Omicron Variant and the re-introduced restrictions on public transport, the Head of Security at the C2C have asked us to communicate with our community and relay the expectations in terms of how students should travel and behave when using the service. Students currently travel in the same 2 or 3 carriages along with members of the public. Whilst social distancing is not a requirement, this can bring students into conflict if not wearing mask – which is a requirement. The C2C ask that students support the service in utilising all the carriages and that movement between carriages are restricted to a minimum. The C2C also expect students to wear face masks and comply with government advice.

# Remote provision – snow days

We thought it prudent to plan and communicate in advance for any potential snow days. Wherever possible, we will keep the school open. However., in the event of a school closure due to snow, parents will be informed by text and on the school website. Remote provision will be provided as follows:

- 1. On the first day of closure, work will be provided on Teams and/or Satchelone for students to complete independently. There will be no live lessons or live registrations.
- 2. From day two, usual remote provision, as per our school policy for a national lockdown, will take effect.
  - All students will have a 'live' morning registration via teams with their tutor at 8.35am; there will be no 'live' check in at the end of the day with tutors.
  - A blended approach to remote teaching will take place which may include 'live' lessons where appropriate and relevant to do so via Teams, but as a minimum, starting off and ending a lesson 'live'.

Any student requiring support with being able to access remote provision should ensure that it is brought to the relevant Head of Year's attention.

## Christmas holiday - Free School Meals

We have just received notification from Southend Borough Council that they will be funding Free School Meal Vouchers for the Christmas holiday period. Please look out for these vouchers which will be emailed to you directly. You will receive a £30 voucher for each qualifying child. If you have any questions, or any difficulties in opening or accessing the vouchers, please contact Mrs Croysdill in the Finance Office who will be happy to assist.

## Information for all education and childcare settings on implementing Plan B of the COVID-19 Response:

#### **Autumn and Winter Plan**

On Wednesday 8 December, the Prime Minister announced the implementation of <u>Plan B of the COVID-19</u> <u>Response: Autumn and Winter Plan</u>, to reduce pressure on the NHS. Plan B sets out a number of additional measures across society to control transmission of COVID-19.

The Government is clear on the critical importance of not disrupting the education of children and young people and the Government will prioritise keeping all education and childcare settings open. The measures set out below will support this.

#### **Attendance**

School attendance remains mandatory and all the usual rules continue to apply. Enabling children and young people to attend their education setting regularly continues to be a national priority. As usual, schools are able to grant leaves of absence for pupils in exceptional circumstances.

## **Face coverings**

Face coverings should be worn by pupils and students in year 7 and above (which would be children who were aged 11 on 31 August 2021), staff and visitors in communal areas, unless exempt. This is a temporary measure. Pupils and students in year 7 and above in these settings must also wear a face covering when travelling on public transport and should wear it on dedicated transport to and from school, college, or higher education provider. We do not recommend that pupils and staff wear face coverings in classrooms, unless their Director of Public Health advises them to temporarily do so in one of the circumstances described in the <a href="Contingency Framework Guidance">Contingency Framework Guidance</a>.

#### Wrap around provision

Schools and early years settings should continue to offer their usual before and after-school activities, including wraparound childcare. These activities provide valuable childcare for working parents and carers and promote the wellbeing of children and young people.

#### Working from home

We expect all education and childcare settings, including further and higher education providers, to continue to provide face-to-face teaching, and staff should continue to attend their place of work if required in order to deliver this. Teaching and learning should not be moved online as a result of the work from home guidance. Following expert clinical advice and the successful rollout of the COVID-19 vaccine programme, people previously considered to be particularly vulnerable, clinically extremely vulnerable (CEV), and high or higher-risk are not being advised to shield again.

Children and young people previously considered CEV should attend their setting and should follow the same COVID-19 guidance as the rest of the population. In some circumstances, a child or young person may have received personal advice from their specialist or clinician on additional precautions to take and they should continue to follow that advice.

## **Testing**

We strongly encourage all those involved in education and childcare settings to continue regular testing (LFD not PCR) and reporting their results, and to encourage pupils and students in year 7 and above to test and report their results.

Settings are strongly encouraged to ask parents, guardians and other visitors to take a lateral flow device (LFD) test before entering the setting.

## Isolation

All individuals who have been identified as a close contact of a suspected or confirmed case of the Omicron variant of COVID-19, irrespective of vaccination status and age, will continue to be required to self-isolate and asked to book a PCR test.

The Government plans to introduce Daily Contact Testing as soon as possible as an alternative to self-isolation for contacts of positive Omicron cases who are fully vaccinated or under the age of 18 years and 6 months.

# January return

We have recently asked all secondary schools to provide an on-site test for pupils on return in January. Testing in school helps to boost participation and will help reduce transmission after a period of mixing over the holidays.
